## Notes

- 1 The 15% cap of the total annual income of parishes averaged for the past three years has been applied and co-operating parishes not under Anglican oversight have been excluded.
- 2 We have assumed the lease at the Church House will be terminated on the 19 April 2024 and no rental income have been allowed for the remainder of the year.
- 3 We have budgeted a modest 6.7% inflation increase for most costs based on the July 2023 CPI published.
- 4 Contributions to WEHCC and ICHC have been adjusted for CPI at 2%.
- 5 This will require management's input and need to be adjusted for the likely financial assistances required.
- 6 Reduced allocation to Diocesan Funded Ministry and Ministry Education compared to previous years. The actual amount the Diocese contributes will depend on how well Ministry Education is performing, i.e. the Diocese only contribute enough for Ministry Education to break even.
- 7 The annual increase for 2024 will be applied from 1 January 2023, as this is when church, financial years begin. 2024 costs have been increased by 6% which is General Synod reccommendation for stipend.
- 8 TML accounting fee has been held at a CPI increase of 2% subject to the underlying organisations/services holding their fees at the same level. The fee has not been adjusted to reflect the change in service scope, e.g. TPC and Heritage churches Taranaki.
- 9 Include all parishes in the Diocese of Waikato and Taranaki. Recoveries of accounting fees are calculated based on % of assessment formula, with a further 50% subsidy (excel GST) per annum.
- 10 Include repair and maintenance on the Church House \$20,000. Earthquake triage/assessments relating to the parish buildings are covered by the Earthquake Risk Fund which is sitting in MSF.
- 11 TPCCG Income and Expenses are based on the Memorandum of Understanding between TPCCG and Diocese of Waikato. We have assumed the contract will be renewed on 31/12/2023 when the current term expires.
